### Who we are

We fund the community with artistic resources and provide student artists with opportunities to thrive within their creative boundaries. The organization aspires to resource student artists with easier access to opportunities such as commissions, competitions, and volunteer work that can aid them in establishing their own artistic portfolios. By working with ADA, artists and individuals may gain valuable experience and improve their skills in areas including, but not limited to, management, research, communication, and artistry.

## **Our Roles**

ADA/AsDA researches commission opportunities for our student artists. We reach out to various organizations to provide these prospects. Artists may gain valuable work experience through commissions. For commissioners, we provide a centralized platform to find artists and commission artworks. We offer a selection of talented student artists to the commissioner, as well as the opportunity to select which artists best fit their needs. Beyond the aforementioned roles, ADA helps manage the communication and negotiation process between artists and commissioners.

### Payment

The company receives a 15% commission fee from the artist's initial 3 commissions. Thereafter, ADA receives a 10% commission fee from each commission.

The artist retains the right to set a price for each artwork according to the company base price. Artists may negotiate with the commissioner through ADA/AsDA. ADA will manage communication between Artists and commissioners.

The commission fee paid by the commissioner will be filed under the company name. ADA must pay the artist 85-90% of the payment settled upon by the artist and the commissioner upon receiving the payment from the commissioner.

A 50% down payment from the commissioner is required for every commission. The commissioner is required to pay the remaining 50% within 10 business days after they receive the commissioned work.

### **Limitations**

The company does not guarantee commission to the artists.

If the commissioner fails to cover the remaining 50% commission fee, the company retains the right to file for lawsuits. The company is not obliged to cover the remaining commission fee.

The company does not cover the cost (of supply and transportation of artwork).

ADA does not guarantee 100% satisfaction from the commission.

The company is not responsible for recompensing commissioners for any damage done to the commissioned work during transportation or any other processes.

#### Violation

Plagiarism of other artists' works is strictly prohibited. If the artist is found to be plagiarizing, they will be blacklisted from the company immediately.

The artist's violation of the contract between the commissioner and the artist will result in ADA blacklisting the artist from the company. The artist will be required to return the 50% down payment, and the company will further return the entire amount back to the commissioner. If the artist refuses to comply, ADA retains the right to file a lawsuit for the violations above. If the commissioner refuses to pay the remaining 50% commission fee, the artists may retain the right to the artwork and the 50% down payment. If the commissioner refuses to return the artwork if already received, the artist retains the right to file a lawsuit.
